



ADVOCACY

Advocating for a More Inclusive World for All People Is at the Core of What We Do

Raising awareness for people with disabilities is key to our advocacy efforts. UCP of NYC self-advocates participated in the 2016 NYC Disability Pride Parade. UCP of NYC also hosted its yearly Family Connect Summit that drew hundreds of practitioners and families seeking the latest information and resources available. In order to widen our borough-based outreach to parents, we organized multiple parent forums, workshops and webinars on topics ranging from Conflict Free Case Management to Helping Your Child with Autism Cope with Anxiety. UCP of NYC also increased visibility for disability issues through positive media placements in the local press.

COMMUNITY CONNECTIONS

Building Bridges and Partnerships for Brighter Futures

Our individuals increased their presence in New York City neighborhoods by teaching students and the community at large about disability at New York's most prestigious educational and arts institutions. Some of these partnerships included an on-going collaboration with New York University's Tandon School of Engineering's Disabilities Course, where our individuals partner with students to create assistive technology projects. Our individuals also continued to partner with the MOUSE Design League, a national organization that offers a year-long after school design and technology program for high school students who learn about applied design, technology and leadership.

IMPACT:

UCP of NYC's individuals became change agents teaching hundreds of students and community members about disability and assistive technology at New York's top educational institutions.



EDUCATION

ADAPT Is the Leader in Providing High Quality Education for Special Needs Children

New York League for Early Learning (NYLEL) joined UCP of NYC. This expanded our educational services to children with special needs to 14 schools, making our preschool network the largest for children with special needs in New York City.

IMPACT:

Our universal pre-kindergarten and integrated preschool programs offered families a high-quality, family friendly learning environment, educating nearly 2,000 children of all developmental levels throughout the five boroughs of New York City.



PHILANTHROPY

Our Philanthropic Endeavors Are Supported by Loyal Donors Like You

UCP of NYC celebrated its 15th and final Women Who Care Luncheon with a special tribute to Loreen Arbus, Founder and Chair who has carried on her parents' legacy through this event with many high-profile female trail blazers and leaders as guests and honorees through the 15 years. 
